Snow Plowing and Parking

For the 2nd year in a row - Jefferson County will continue to plow the subdivision, saving the HOA approximately \$8,000-\$10,000 per season.

As a reminder, and per current HOA indentures, no parking is allowed on streets (with exception for emergencies). Street parking only delays the clearing of roads and salting. This is also a violation by fire department code as a fire lane must be maintained.
